RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA CRUZ TO INCREASE FEES FOR THE BOAT STORAGE PROGRAM AT THE LOCH LOMOND RECREATION AREA AND RESCINDING RESOLUTION NO. NS-29,482 IN ITS ENTIRETY

WHEREAS, Title 16 of the Santa Cruz Municipal Code provides the rules and requirements governing the administration and operation of the City's Water System, including identification of the various sources of authority to establish and amend Loch Lomond (LL) Recreation Area fees by Resolution; and

WHEREAS, on January 19, 2019 the City Council adopted Resolution No. NS-29,482 to revise the Loch Lomond Recreation Area fee schedule; and

WHEREAS, proposed fees reflect the Bay Area Consumer Price Index increase since the last fee schedule was approved and includes market rate increases for boat rentals; and

WHEREAS, the City Council has determined that the fees are appropriate and are important to support the recreational activities at Loch Lomond;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Santa Cruz that Loch Lomond Recreation Area fees will be charged as follows:

- \$325 – Entire Season
\$175 – After June 15th
- (Includes Launching & AIS Decontamination for Trailerred Boats)
- \$425– Entire Season
\$275 – After June 15th
4. Aquatic Invasive Species (AIS) Inspection and Decontamination
- \$30 – Each time boat is removed from LL Area and returned to storage

SITE RESERVATION FEES

1. Group Picnic Sites \$70– All Day
2. Wedding Venue \$250 – All Day

BEER / WINE CONSUMPTION PERMIT

1. Addition to Group Picnic Site Use \$60 – All Day
2. Individual Daily Permit \$6 – All Day

Section 2. EFFECTIVE DATE

This resolution shall be effective November 1, 2023.

BE IT FURTHER RESOLVED that all Loch Lomond Recreation Area fees established by Resolution No. NS-29,482 are rescinded in entirety.


