SUBJECT: Rail Trail Mural Artist Application Review Panel

RECOMMENDATION: Motion to appoint an Arts Commissioner to serve on the Rail Trail Mural Artist Application Review Panel

Background:

The Monterey Bay Sanctuary Scenic Trail (Rail Trail) is runs a 3.7 mile length through the City of Santa Cruz. A multi-year City Arts planning process led to development of the Santa Cruz Rail Trail Arts Master Plan (Rail Trail Arts Plan) which was presented to City Council in the spring of 2018. Segment 7, Section 1 construction has been completed. The first art installation, A Feast of Flowers by Jenni Ward has been fabricated and is planned to be located near the Natural Bridges Drive terminus in what is referred to in the Rail Trail Arts Plan as Corridor 1: The Old Wrigley Building. Permission has already been secured for installation on the private property side of the Rail Trail. Details for approval are still being negotiated with the Santa Cruz Regional Transportation Commission (RTC), owners of the Rail Trail.

Segment 7, Section 2 is currently under construction. A timber lag retaining wall that was originally planned for most of one side of the length of that leg of the Rail Trail. Because of technical issues, a section of the retaining wall, approximately 900 square feet will be concrete instead. In the Rail Trail Arts Plan this site is referred to as Corridor 6 – The Neary Lagoon Part 3. It is quite close to the Gateway 4 Trestle site that is also identified in the Rail Trail Arts Plan.

Discussion:

The concrete wall planned for Corridor 6 is essentially a blank canvas that calls for a Santa Cruz mural. The location is very close to the Wharf Roundabout and the Monterey Bay National Marine Sanctuary Exploration Center. The Roaring Camp train runs on the tracks there so the mural will be very visible to all who take that ride. Photos of the site are attached. The concrete retaining wall is expected to be completed in March of 2024. The City Arts staff is now planning to issue a call for artists (RFP) to fabricate/install a mural as close to the completion date as possible.

According to the current timeline, an RFP will be released in early January. An application review panel will be formed that will include City Staff, Arts Commission representation, and stakeholder representatives from nearby businesses and the MBNMS Exploration Center. At this time, the Arts Commission is being asked to appoint a representative to this group. It is expected that this work will involve a time commitment of 8-10 hours depending on the number of

submissions that are received. The review panel work will take place during the months of February and/or March.

The final mural proposal will be brought to the full Arts Commission in 2024 for review and approval after an artist is selected.

Equity, Inclusivity, and Environmental Justice

The Arts Commissioner on the Rail Trail Mural RFP evaluation committee will represent and advocate for the Arts Commission commitment to equity, inclusivity, and environmental justice. In this context it could mean that the Commissioner specifically reviews the applications as they promote accessibility, capacity building, cultural representation & integrity and the creating and strengthening of partnerships with underrepresented and marginalized groups.

<u>Fiscal Impact:</u> None at this time. The current budget for this mural is \$30,000. This cost will be split between the City Arts and Public Works. Fixed cost will be determined during the negotiation period with the artist chosen through the RFP process.
